## **MINUTES**

November 29, 2018

### **1. Call to Order**

## **8. Executive Director's Report**

### Civic Center TV

Commissioners were provided a report of programming produced for Civic Center TV in November.

Mr. Scott addressed the Commission regarding his presentation to the Cable Community Panel on November 28 and the opportunity to interact with the members, CCT viewership as measured by web metrics, high school football coverage on WBLD, CCT involvement in the Veterans' Day breakfast at Orchard Mall. He also mentioned the new monument sign in front of Green Media Center, the new host of "The Splash", Brooke Allen, and holiday hours at GMC.

In response to a question from Mrs. Dziuba, Mr. Scott stated that radio and television broadcast rights for high school athletics are controlled by the Michigan High School Athletic Association and that WBTV, being operated professionally and not by students, is not authorized to provide coverage. The Executive Director added that student production teams in Lake Orion and Clarkston do provide tape-delayed video coverage of home football games.

### Cable Operators

Commissioners were provided copies of communications from Comcast regarding channel line-up changes and rate increases effective January 1, 2019.

### GWBCCC Directory

Members were provided an updated directory of Commission membership, contractors, and committee assignments.

### Election of Officers

Pursuant to the its bylaws, the Commission will elect its officers for 2019 at the January 10 meeting. In advance of that meeting, a summary of commissioners' interest in serving will be provided.

### Cable Industry News

Between the first quarter of 2017 and the first quarter of 2018, one-third of all pay TV subscribers made changes to their service. Fifteen percent downgraded, ten percent upgraded, and five percent re-subscribed after going without service for a year or more.

The CEO of Comcast-owned NBC Universal has stated that the growth of streaming services is flattening. DirecTV Now, owned by AT&T, added 342 thousand subscribers in the second quarter of 2018 and just 49 thousand in the third quarter.

AT&T is moving away from wire-line cable (U-Verse) and satellite service (DirecTV) and wants to be providing all services via streaming by 2020. Because of lack of high-speed internet, rural subscribers will be most affected.

## Communication

No communication was received.

## Commission Assistance to Residents

The Commission has always dealt with unburied cable situations, the last several months being no exception.

Another recent inquiry involved intermittent service, and the advice provided to subscribers is to make sure the operator checks the residential drop, service from the pole or pedestal to the home and to make sure all services are working before the technician leaves the premises after a service call.

## Preview

The Executive Director presented his agenda for the time period between this meeting and the next.

Mrs. Macon suggested that the Commission find a way to communicate the advice communicated to subscribers regarding intermittent service to all residents.

In response to a question from Ms. Dahl regarding the role of social media in publicizing events and securing video, Mr. Scott stated that the Community Programming Committee has discussed and will discuss the possibility of new initiatives in that area. Mr. Krause added that nextdoor.com may be another useful avenue.
