## **8. Executive Director's Report**

### Civic Center TV/Lakes FM

Mr. Scott addressed the Commission regarding the operation of Civic Center TV and Lakes FM, focusing on the installation of Chamber of Commerce officers and United We Walk in January, the upcoming vaccine townhall and a Parks and Recreation cooking show for Black History Month later in February, the State of the Communities in late March, and the Michigan Week Awards in May.

He also noted the upcoming transition of Lakes FM into the television studio at Green Media Center, making the Megacast look better for TV and allowing one person to host and produce the show. Also mentioned was the new West Bloomfield fiber optic wide area network and the ramifications for Keego Harbor and Sylvan Lake meeting coverage. Mr. Scott stated that it was his honor and pleasure to be able to broadcast the West Bloomfield Lakers championship football game from Ford Field in January.

## Cable Operators

Commissioners were provided copies of communications from Comcast regarding price increases, channel line-up changes, and its “Lift Zones” initiative bringing internet service to community centers in low-income areas.

## GWBCCC Directory

Members were provided an updated directory of Commission membership, contractors, and committee assignments.

## Cable Industry News

President Biden has appointed Commissioner Jennifer Rosenworcel as acting chair of the FCC. The Commission will therefore have two Democrats and two Republicans until the nomination of another Democrat as the fifth member. The new FCC is expected to exhibit less of a de-regulatory agenda than the body under Republican leadership. Whether that might include rescinding the 2019 franchise fee order remains to be seen.

Comcast’s plans to impose a data cap on internet subscribers in 12 northeastern states has been delayed until July. Subscribers in the other 27 states in the company’s footprint have been subject to the same caps since 2016.

Comcast is increasing its efforts to bring broadband to underserved communities through higher speeds for its Internet Essentials subscribers, the establishment of “Lift Zones”, community centers equipped with internet service for public use, and grants to digital equity and social justice organizations.

## Communication

No communication was received.

## Commission Assistance to Residents

Two telecommunications pedestals in the back yard of a home in West Bloomfield are being impacted by the growth of a tree branch, one to the point where it has been forced open, exposing the wiring inside. The pedestals belong to Comcast and AT&T, and both companies have been asked to rectify the situation.

A resident was having difficulty closing the account for a deceased parent, including the return of Comcast equipment. At the Commission’s request, the company resolved the situation.

Two subscribers contacted the Commission regarding recent significant price increases, and in each case, the expiration of a promotional deal was the reason. Comcast worked with the

Commission to contact the residents, explain the billing, including what items are and are not included in promotional agreements, and reconfigure the service.

## Preview

The Executive Director presented his agenda for the time period between this meeting and the next.

Mrs. Macon related accolades from West Bloomfield Board of Education Trustee Christy Forhan regarding Laker Football broadcasts on Lakes FM.

In response to her question regarding the impact of the new radio/TV studio, Mr. Scott stated that the reconfiguration will benefit both Civic Center TV and Lakes FM, improving programming on both resources as well as increasing studio rental opportunities for audio and video podcasts as well as other programming.

Mrs. Macon suggested that any segment of the State of the Communities dealing with school districts include all districts in the Greater West Bloomfield area.

In response to her question regarding Comcast Lift Zones, the Executive Director stated that currently all southeast Michigan locations are in the city of Detroit and that the initiative is not directly related to Internet Essentials.

Mrs. Macon thanked the Executive Director for his assistance regarding the two pedestals in her back yard.

Mr. Ross commended Mr. Scott for the Lakes FM coverage of Laker Football.

Mr. Warshay stated that the West Bloomfield Township Board adopted a resolution in support of Sunshine Week at its February 8 meeting. He added that AT&T, unlike Comcast, does include on the monthly bill all promotional deals and the expiration of those agreements.

Mrs. Dziuba noted needed revisions to the GWBCCC directory.

Ms. Levine thanked Civic Center TV for its coverage of the installation of Chamber of Commerce officers in January and noted the advantages of the virtual format and the contributions of Ronnie Dahl in interviewing the Board members.
