Cable Operators

No information was received from Comcast or AT&T.

Cable Industry News

The Convergence Research Group reports that the revenue of streaming providers increased by 35 percent in 2020 and will double by 2023. Traditional pay TV (cable, telephone providers, satellite) decreased 6 percent in 2020 and is projected to decrease 6.5% this year and 10 percent by 2023. 42 percent of U.S. households do not subscribe to a pay TV service this year, and that number will increase to 60 percent by 2023.

The American Customer Satisfaction Index reports that the highest rated TV subscription service is AT&T U-verse, which the company has not offered to new subscribers since April of 2020. Rated third in customer satisfaction is DirecTV, which AT&T has sold as the company gets out of the subscription TV business.

The federal Emergency Broadband Benefit has been available to eligible low-income households since May 12, and in the first three weeks, 2.3 million have enrolled. The program provides a 50 dollar per month subsidy for broadband service and a one-time discount of 100 dollars on a computer or tablet until the 3.2 billion dollar program runs out of funding.

Communication

No communication was received.

Commission Assistance to Residents

A resident who is moving to Macomb County in mid-June established service at his new residence in mid-May and found that his West Bloomfield service had been disconnected. At the Commission's request, Comcast re-connected the service and granted a credit for the inconvenience.

On behalf of one of the commissioners, the Commission asked Comcast to dispatch a senior technician to review all equipment and wiring infrastructure in the residence. The commissioner reports a very successful service call and that all problems are resolved.

A resident was promised credit for intermittent Comcast internet service, which was not granted until the Commission communicated the request.

A resident stopped receiving his monthly bill via USPS and was told that he had switched to paperless billing, which he had not. After several miscommunications and late payment penalties, the Commission asked Comcast to contact the subscriber, clear up the misunderstanding, and grant credit where appropriate.

Recommendation of the Commission Operations and Strategic Planning Committee – GWBCCC Meeting Schedules

- 2) in-person committee meetings at the currently scheduled time at Green Media Center.”
