### GWBCCC Meeting Schedules

Members were provided 2021 meeting schedules for the Commission and its three standing committees, updated as a result of the return to in-person meetings approved by the West Bloomfield Township Board on June 21.

Mr. Warshay stated that when the Township Board voted in June to return to in-person meetings in September, it did not rescind its emergency declaration, allowing the Cable Commission and several other bodies to determine independently whether their meetings will remain virtual.

## Cable Industry News

The Federal Communications Commission currently has 4 members, 2 Democrats and 2 Republicans. President Biden is being urged to appoint a fifth commissioner by those hoping that a number of issues, including net neutrality and the Commission's 2019 franchise fee order, will be resolved. Fifty national organizations, including the ACLU, American Libraries Association, Electronic Frontier Foundation, and Writers Guild of America, have called for the re-instatement of net neutrality rules repealed by the Trump administration FCC under Chairman Ajit Pai.

## Communication

Commissioners were provided copies of letters from the Commission's contractors, Motown Digital and Cable Commission Consulting, stating their desire to continue to provide services in 2022.

## Commission Assistance to Residents

A resident asked the Commission to assist in securing Comcast attention to her slow and intermittent internet service. The situation was resolved to some degree, with her understanding that part of the problem is her computer hardware.

The Commission continues to receive calls from subscribers who agreed to a fixed rate for service for 1 or 2 years and then find the cost increasing. The problem often involves the expiration date of the rate agreement and a lack of clear communication regarding costs (equipment, broadcast and regional sports surcharges, taxes and fees) that are not included in the agreement.

An Orchard Lake resident contacted the Commission regarding Comcast cable hanging from tree branches in her backyard. The Commission requested that Comcast attach the cable to poles along Pontiac Trail, which was completed after the issuance of a permit by the Road Commission for Oakland County.

## Preview

The Executive Director presented his agenda for the time period between this meeting and the next.

Mrs. Macon arrived at 6:55PM. She thanked the Executive Director for his assistance with AT&T infrastructure in her back yard.

Mr. Warshay stated that AT&T does provide notification to subscribers when promotional rates expire.

In response to a question from Mrs. Macon, the Executive Director stated that the newest Xfinity

modem is the Xb7. He added that if a subscriber upgrades the modem at an Xfinity store, it is important to ask the sales representative to leave the one in service operational until the new one is installed and functional and the older one is returned. Mr. Ross stated that he owns his own modem, a DOCSIS 3.0, and that it works very well.
