## MINUTES

October 14, 2021

### 1. Call to Order

The meeting was called to order by the Chairperson, Harvey Gersin, at 6:32PM via ZOOM teleconference. He stated that the meeting is virtual pursuant to the Michigan Open Meetings Act and the West Bloomfield Township Emergency Declaration, approved in March 2020 and renewed in March 2021.

### 3. Approval of Agenda

##### Report of the Commission Operations and Strategic Planning Committee

Commissioners were provided a written report which was summarized by Mr. Kowalsky, the committee chairperson.

The Executive Director thanked Ms. Attisha and Mrs. Macon for their contributions to the strategic plan being recommended for Commission approval later in this meeting and their

continuing involvement in the process leading to the implementation of that plan. Ms. Attisha stated that she has enjoyed working with Mrs. Macon, the Executive Director, and other Commission members.

Mr. Warshay noted that he has been appointed liaison from the West Bloomfield Township Board to the Planning Commission and will be leaving the Cable Commission at such time as his successor is appointed.

Mrs. Macon stated that Ms. Attisha's willingness to continue working on the strategic plan although no longer a commissioner provides an opportunity for the Commission to develop a policy regarding the role of skilled volunteers in its work. She added that there are many in the community ready to step forward and help, and she requested that such a policy be placed on a future committee agenda.

#### Report of the Community Programming Committee

Commissioners were provided a written report which was summarized by Mrs. Dziuba, the committee chairperson.

### **8. Executive Director's Report**

#### Civic Center TV/Lakes FM

Commissioners were provided a report of programming cablecast on Civic Center TV in September and early October.

#### Cable Operators

No information was received from Comcast or AT&T.

### GWBCCC Directory

Members were provided an updated directory of Commission membership, contractors, and committee assignments.

### 2022 GWBCCC Budget

The budget was approved by the West Bloomfield Township Board on October 4 and the Sylvan Lake City Council on October 13. It will be considered by the Orchard Lake City Council on October 18 and the Keego Harbor City Council on October 21.

### Cable Industry News

Two dozen members of the United States Senate are urging President Biden to nominate Jennifer Rosenworcel as the permanent chairperson of the FCC. Local communities are hoping that under her leadership the Commission will reconsider its 2019 franchise fee order, which she opposed.

Analysts predict that the pay TV industry will lose 33 billion dollars in revenue by 2025, down to 64 billion from the peak of 116 billion in 2016. That would be a 45 percent decrease in 9 years.

In addition to providing cable, internet, and telephone service, Comcast is now selling smart TVs with its flex operating system.

Some interesting statistics have been released regarding streaming versus traditional broadcast and cable TV.

- 214% more people are likely to watch news via traditional TV
- 73% more people are likely to watch sports via traditional TV
- 153% more people are likely to watch young adult content via streaming
- 75% of streaming content is viewed on a TV screen

### Communication

### Commission Assistance to Residents

The Commission has received a number of communications recently regarding pedestals which are damaged and/or an aesthetic eyesore.

Two of them (one Comcast, one AT&T) are side-by-side next to a safety path on Long Lake Road. Comcast has repaired its unit; AT&T has not.

One is at a residence and has been straightened but needs a replacement cover.

An Orchard Lake resident has repeatedly asked Comcast to provide via email her monthly invoice which she auto-pays via credit card. The Commission is working with the subscriber and Comcast to make that happen, not necessarily easy because the default is a comcast.net email address.

Mrs. Macon stated that she enjoyed working with Ms. Attisha and the Executive Director and appreciates the trust placed in that group by the Commission. She added that the objectives included the plan are for 2022 only, with on-going monitoring and review at the end of the year.

Mr. Kowalsky urged commissioners to review the document and share it with others as a representation of what the Commission strives to accomplish.

Motion by Mr. Gersin, support from Mr. Warshay:

“That the Greater West Bloomfield Cable Communications Commission accept the resignation of Phil Ross from the Commission Operations and Strategic Planning Committee.”

Mr. Ross stated that he has a Monday evening commitment which runs until May, at which point he will be able to rejoin the committee.

Mrs. Macon noted that the Commission has discussed the development of supplemental revenue sources and mentioned “Giving Tuesday” as a possible focus. She announced that Rochelle Riley will address West Bloomfield Rotary on October 28 at Sposita’s on 14 Mile Road and that the United We Walk MLK Book Club will discuss Dr. King’s final book “Where Do We Go From Here”. She also highlighted the West Bloomfield School District’s strategic planning initiative and mentioned the on-line survey and a general meeting to be held at the high school on October 18 at 4:00PM.
