## **MINUTES**

March 10, 2022

### **1. Call to Order**

The meeting was called to order by the Chairperson, Harvey Gersin, at 7:00PM at West Bloomfield Town Hall.

#### **4. Recognition of the Contributions of Chuck Scott**

The Chairperson stated that it is the Commission's privilege this evening to recognize the contributions of Chuck Scott to WBLD, Lakes FM, and to present a plaque to members of his family in attendance at the meeting.

At the invitation of the Chairperson, the Executive Director provided background information regarding Mr. Scott's contributions to the creation of Radio Station WBLD in 1974 and its upgrade in 2015, focusing on the decision of the West Bloomfield School District Board of Education to use a special project gift to construct the station and the involvement of former student Chuck Scott, a professional radio engineer, in that construction. He was also involved when the Cable Commission offered in 2015 to upgrade and operate the station on behalf of the District.

Mrs. Dziuba read the inscription on the plaque.

“The Greater West Bloomfield Cable Communications Commission gratefully acknowledges Chuck’s outstanding contributions in the design and construction of Radio Station WBLD at West Bloomfield High School in 1974.

Chucks technical skills and expertise were invaluable in that project and also in 2015 in the upgrading of the transmitter and antenna.

We gratefully appreciate and celebrate the legacy of his talent, gifts, and the generous sharing of his time and abilities.”

She then presented the plaque to Chuck's sister Deborah Katz, brother Dave Scott, and daughter Krista Scott.

The Chairperson thanked Mrs. Dziuba for her leadership in this recognition.

Mr. Scott thanked the Commission for the recognition and added that family members living in Petoskey were watching the meeting this evening. Ms. Katz also thanked the Commission for recognizing her brother's contributions.

Mrs. Macon stated that she will vote in favor of the committee recommendation and that her vote against the revision of the objectives in the committee reflects the feelings of the two skilled volunteers involved in the process of creating the original objectives and that those feelings are not stated appropriately in the meeting report. She added that the revisions could have been put in place through the creation of the one-year accomplishment plan as the volunteers had recommended. She stated that she will offer questions regarding the process later in the meeting, questions absolutely crucial to organizations that want to follow a coherent strategic plan.

## **9. Executive Director's Report**

### Civic Center TV/Lakes FM

Commissioner were provided a written report of programming cablecast on Civic Center TV in February.

Mr. Scott noted the 2022 State of the Communities presentation on Civic Center TV, debuting on March 14 at 7:00PM and subsequently available via replay and on-demand. He also reported that the Michigan Week Community Awards Breakfast will take place and be cablecast live on CCT on Friday, May 13. He added that the West Bloomfield Educational Foundation 2022 fundraiser will be occur on Thursday, April 21 and be cablecast on WBTV.

Mr. Scott reported that additional communities in Oakland County will be joining the Megacast network in coming weeks. He thanked the Chairperson and committee members for their efforts in raising public awareness of the Commission's programming resources and presented web metrics regarding the reach of Civic Center TV.

The Chairperson thanked Mr. Scott for the outstanding programming produced by his staff and for mentioning promotional material created for public distribution.

## Cable Operators

## GW BCCC Directory

Members were provided an updated directory of Commission membership, contractors, and committee assignments.

## Cable Industry News

The default streaming device for a majority of viewers is now a television set, replacing computers, tablets, and smartphones.

A survey has revealed that 44 percent of cable subscribers would cancel their service if live sports coverage was offered via streaming. Starting this fall, NFL Thursday Night Football will be exclusively on Amazon, a streaming service.

The Senate Commerce Committee voted 14 to 14 to send the FCC nomination of Gigi Sohn to the full Senate. A tie vote moves the nomination along but does not include a recommendation for approval. A vote in the Senate is expected within a month or two barring the placement of a hold on the nomination by any senator.

The Emergency Broadband Benefit, offering qualifying households discounts on internet service, has been reconstituted and renamed the “Affordable Connectivity Program”.

## Communication

No communication was received.

## Commission Assistance to Residents

Cable service concerns communicated in the past month to the Commission included those which have been around for many years, including billing and service concerns. In each case, the Commission’s efforts to create direct communication between the resident and the company have resulted in resolution.

The Commission has also been contacted by residents who purchase Comcast services via solicitation by a third party. These transactions sometimes involve misunderstandings regarding rates and services, but Comcast has always worked with subscribers to resolve any problems.

Ms. Levine stated that the Greater West Bloomfield Chamber of Commerce is resuming in-person events in April starting with the “Cup of Connections” on the second Friday of every month. On June 8, the Chamber, along with West Bloomfield Township and WB Parks, will sponsor the Health and Wellness Fair at Town Hall. She also announced a July 20 multi-chamber event at Suburban Collection Showcase in Novi.

Mrs. Macon stated that the deadline for Michigan Week nominations is March 11 at 11:59PM and added that tickets to the May 13 breakfast at Wabek Country Club will be on sale soon at [michiganweek.org](http://michiganweek.org).

She asked when each of the three standing committees will present its first update regarding 2022 implementation of the Commission’s strategic plan. She also stated that the Finance Committee may need to review the strategic plan in order to determine if revisions are necessary in light of its objective of seeking additional revenue through grants. She suggested that participation of commissioners who are not members of the Finance Committee in the committee’s preparation of an IRS 501(c)(3) application should be done in a Committee of the Whole setting.
