Civic Center TV/Lakes FM

Commissioners were provided a written report of programming cablecast on Civic Center TV in March.

Cable Operators

Commissioners were provided copies of a communication from Comcast regarding pricing and line-up changes.

Cable Industry News

Following the withdrawal of the nomination of Gigi Sohn to the FCC, a few names have surfaced as possible presidential nominees to fill the open seat on the Commission. Those being mentioned are not household names but have substantial federal government experience in both the executive and legislative branches.

The chairperson of the Commission has proposed a rule mandating transparency in subscriber billing for cable television services with a clear bottom-line price and specificity regarding taxes, fees, and surcharges.

The Affordable Connectivity Program, which provides broadband service to qualifying households at a 30 dollars per month discount, has now enrolled 17 million families across the country, and the FCC is working to increase that number through a simpler application process.

87 percent of U.S. homes with an internet connection subscribe to at least one streaming service, and 44 percent of those homes also watch linear pay TV.

The revenue that broadcast television stations receive from pay TV operators for inclusion of their signals in cable service increased 3 percent over the past year despite the fact that broadcast viewership and pay TV subscriptions have decreased.

Communication

No communication was received.

Commission Assistance to Residents

The Commission is assisting an Orchard Lake resident who reported lawn damage caused by a Comcast truck.

The Commission is working with West Bloomfield regarding several AT&T infrastructure problems in the Township.

Comcast, at the request of the Commission, worked with a subscriber whose promotional rate had expired and instituted a new promotional offer.

A resident with an email issue was directed by the Commission to the Xfinity store in Bloomfield Township, where staff was able to resolve the problem.

Preview

The Executive Director presented his agenda for the time period between this meeting and the next.

In response to a question from Mr. Kowalsky, the Executive Director stated that although AT&T is no longer marketing its U-verse cable television product, it is offering internet service to residents.

Mrs. Macon stated that April is Global Volunteer Month and that the week of April 17-23 is National Volunteer Week.

She invited all commissioners to the May 4 meeting of the Clergy Association and Community Forum at the Recreation Activities Center, which will celebrate the National Day of Prayer on that day. She also noted the Michigan Week Community Awards Breakfast on May 12, with registration required at a cost of 30 dollars. She added that residents from all four Greater West Bloomfield communities are being honored.

Mrs. Macon also mentioned the handbook for members of boards and commissions on the City of Keego Harbor web site.

Mrs. Macon mentioned the United Way of Southeast Michigan 21-day Equity Challenge in May and June and asked that the initiative be placed on the agendas for the May 1 meeting of the Commission Operations and Strategic Planning Committee and the May 11 Commission meeting. She noted the recent release of new ALICE (asset limited, income constrained, employed) figures for Greater West Bloomfield.

In response to a question from the Executive Director, Mrs. Macon stated that the May 4 event is both the monthly meeting of the Clergy Association and Community Forum and the local celebration of the National Day of Prayer.
