Members were provided an updated directory of Commission membership, contractors, and committee assignments.

Cable Industry News

President Biden has nominated Anna Gomez, Geoffrey Starks, and Brendan Carr to the Federal Communications Commission. Starks, a Democrat, and Carr, a Republican, are re-appointments, while Gomez, a Democrat, is a new appointment to fill the long-vacant fifth seat on the Commission. She is a long-time DC insider, having worked at the National Telecommunications Information Administration in the Obama administration. A number of trade associations are urging the Senate to confirm all three appointments quickly, citing the need for a functional FCC to ensure certainty and stability in telecommunications regulation.

Thus far in 2023, broadcast television is slightly down while cable viewing is slightly up. Year to year, cable is down 12 percent, broadcast down 4.

The American Customer Satisfaction Index has once again recognized AT&T's U-verse as number 1 in customer satisfaction among telecommunications services, despite the fact that the company has not offered U-Verse since 2020. Subscribers rate Comcast near the bottom.

Communication

No communication was received.

Commission Assistance to Residents

The commission is assisting residents in facilitating the burial of unburied cable, one belonging to Comcast and one to AT&T.

A subscriber whose lawn was flagged for underground work last year, which never occurred, and was flagged again this spring inquired of the Commission whether the work would occur this year. Comcast responded to a Commission inquiry, stating that the flags should be removed.

The Commission is continuing to work with West Bloomfield regarding AT&T infrastructure problems around the Township.

Preview

The Executive Director presented his agenda for the time period between this meeting and the next.

Mr. Ross noted that Comcast is now charging its subscribers for the premium streaming service

Peacock, which the company had been providing at no cost.

In response to a question from Mrs. Macon, the Executive Director stated that his tenure on the NATOA Board of Directors ends on October 5. She asked that the Commission formulate some type of recognition of his service.

9. Unfinished Business

No items of Unfinished Business were presented.

10. New Business

August GWBCCC Meeting

Motion by Mrs. Macon, support from Ms. Levine:

Mrs. Macon stated that she is looking forward to Commission reflection and self-assessment to be conducted at that meeting under the direction of the Executive Committee.
