Civic Center TV/Lakes FM

Commissioners were provided a written report of programming cablecast on Civic Center TV in June and early July. The Executive Director noted the final episode of the Megacast on July 5 and the debut on July 6 of The Splash Live as the morning and early afternoon programming on CCT.

Mrs. Macon suggested a friendly challenge among commissioners to watch two or three episodes of The Splash Live each week.

Cable Operators

Commissioners were provided copies of a written communication from Comcast regarding price changes.

GW BCCC Directory

Members were provided an updated directory of Commission membership, contractors, and committee assignments.

Cable Industry News

The Leichtman Research Group reports that 74 percent of U.S. households now own at least one smart TV.

A report from the accounting firm PwC, focusing on long-terms trends in telecommunications, forecasts traditional television (broadcast, pay TV) revenue dropping 2 percent from 2022 to 2027 while streaming revenue will increase 16 percent during the same time period.

22 percent of adults in the U.S. have canceled a streaming service in the past three months, citing insufficient use as the reason. As a result, Americans are spending more on streaming but using fewer streaming services.

The Senate Commerce Committee has approved FCC nominees Anne Gomez, Geoffrey Starks, and Brendan Carr and sent the nominations to the full Senate. Approval of all three would bring the Commission to a full complement of five members for the first time in nearly three years.

The FCC is seeking comments regarding a proposal to require comprehensive bottom-line pricing for all video services. One of the sticking points is how to label taxes and fees and differentiate them from programming costs.

Communication

No communication was received.

Commission Assistance to Residents

The Commission has worked with cable operators to have two cables buried.

The Commission also referred two billing issues to Comcast on behalf of subscribers, one involving the expiration of a promotional rate and the other new bank account information for autopay after a previous bank account was hacked.
