8. Executive Director's Report

Civic Center TV/Lakes FM

Commissioner were provided a written report of programming cablecast on Civic Center TV in October and November.

Cable Operators

Commissioners were provided copies of two communications from Comcast.

Election of Officers

The Executive Director stated that, pursuant to the Commission's bylaws, the election of officers for 2024 will be held at the beginning of the January 11 meeting and that commissioners will be asked to communicate in advance of that meeting their interest in serving as an officer.

Cable Industry News

The cable industry has identified a group of subscribers, the “quiet quitters”, who have not cut the cord but are viewing less pay TV. The downside for the industry is that these customers may decide to disconnect their service at some point, and fewer viewers means lower advertising revenue. Pay TV constitutes 46 percent of all television viewing, 77 percent of the sports audience, and 85 percent of the news audience.

In September, streaming was down 5 percent and broadcast television up 13 percent, mostly the effect of football coverage. Consumer spending on streaming was up 17 percent from the third quarter of 2022 to the third quarter of 2023.

ESPN, which has been identified as the most valued cable channel among subscribers will “go to streaming” at some point, according to Disney president Robert Iger. He added that the service will also remain on cable.

Subscribers are less likely to cancel multiple-channel streaming services, like You Tube TV, Hulu Live, and Sling TV, which offer dozens of channels in one service, than pay TV. The likelihood of cable cancellation is 21 percent, while streaming is 12 percent.

Commission Assistance to Residents

A resident of a West Bloomfield condominium complex contacted the Commission regarding a damaged pedestal and exposed wiring. Comcast was notified and rectified the situation.

The Commission responds to periodic calls from subscribers regarding billing issues by asking Comcast to contact the resident or by recommending a visit to the Xfinity store on Telegraph in Bloomfield Township. Both avenues have yielded positive results.

A resident contacted the West Bloomfield Township Supervisor's office to express dissatisfaction with cell service in his area of the Township. He was informed that neither the local community nor the Cable Commission have any control over cell service.

Preview

The Executive Director presented his agenda for the time period between this meeting and the next.

Mrs. Macon mentioned the concept of the digital forward consumer who is technologically adept and conducts most daily business digitally.
